Overall Progress Narrative:

The four AMTs were approved by the Clayton County Commissioners in October, 2009, however they did not receive their contracts or the Notice to Proceed until January 22, 2010. The contracts were issued from Clayton County's Central Services Department. We immediately held a meeting on January 25th of all AMTs to review the policies and procedures and set into place a web based Reservation system. This purpose of this system is to reduce internal competition for the same properties and provide a tracking system during the acquisition stages. The AMTs immediately began the process of reserving houses and completing work write-ups in preparation for acquiring the properties.

By early March, all AMTs had negotiated on and put under contract 28 houses. The due diligence process began, which includes appraisals, inspections and title work, and these were completed on all 28 houses before they were acquired. All the houses were closed during the month of March and the rehab work began.

Each AMT consists of a general contractor and a listing agent in order to move our sales program forward quickly. As of March 31, there were 3 contracts to sell the houses, 4 contracts pending plus Habitat's buyers reported below. As part of our marketing strategy we decided to hold a Block Party for the existing property owners in the neighborhood, interested buyers and the public. We held our first block party and open house on March 13, at Tara Oaks in Riverdale. Habitat for Humanity purchased 17 houses in Tara Oaks and all are dedicated to families who meet our very low income threshold. On the day of the event, we had a total of 16 families interested in purchasing and by March 31st Habitat had been able to qualify three of those families to purchase. The event was covered by local TV and radio. Georgia Representative David Scott and Gail Hambrick, the District County Commissioner, were present.

To ensure we are meeting our schedule to obligate our funds and to stay current with our AMT&rsquos we have scheduled monthly meetings with the AMTs. During these meetings we review the progress each is making, discuss any impediments to purchasing or selling, possible solutions and offer resources and assistance where needed. This has been very beneficial to the overall program and created a sense of teamwork to achieve the County&rsquos goals.

Two people from our office attended the HUD DRGR training on March 9, 2010.

To promote and educate the public about the NSP in Clayton County, we provide Buyer Informational meetings, and are first targeting the employees of Clayton County that do not live in the County. We held the first two events on March 23 and March 26, and more are planned for the next quarter.
